My name is Bruce Green and I am the CEO of SPF International Corporation operating as Secure Platform Funding who owns and operates the web site [www.SecurePlatformFunding.com](http://www.SecurePlatformFunding.com). A website that your company hosts (according to WHOIS information) is infringing on at least multiple copyrights owned by our company.

**An article was copied onto your servers without our permission, authority, knowledge or consent, breaching our copyright and causing immediate harm to our business. You are required to IMMEDIATELY REMOVE THE UNAUTHORIZED AND INFRINGING COPY THAT HAS BEEN STOLEN FROM OUR BUSINESS.**

This letter is official notification under [Section 512\(c\)](#) of the Digital Millennium Copyright Act ("DMCA"), and I seek the removal of the aforementioned infringing material from your servers. 
